Books Between Kids – Minor Liability Waiver 2022-23

Thank you for your interest in volunteering with Books Between Kids (“BBK”). Please read and acknowledge your agreement to the following in consideration of the opportunity afforded you to volunteer with BBK:

1. I understand that the scope of my relationship with BBK is limited to a volunteer position and that no compensation is expected in return for services provided by me to BBK and that I am responsible for my own insurance coverage in the event of personal injury or illness as a result of the services I provide to BBK.
2. I agree to release and forever discharge and hold harmless BBK and its agents, representatives, employees, officers, and board members from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from the services I provide to BBK. I understand and acknowledge that this release discharges BBK from any liability or claim that I may have against it with respect to bodily injury, personal injury, illness, death, or property damage that may result from the services I provide to BBK or that may occur while I am providing volunteer services.
3. I further understand that BBK does not assume any responsibility for, or obligation to provide me with, financial or other assistance, including but not limited to medical, health, or disability benefits or insurance. I expressly waive any such claim for compensation or liability on the part of BBK beyond what may be offered freely by BBK in the event of injury or medical expenses incurred by me.
4. I release and forever discharge BBK from any claim whatsoever which arises or may hereafter arise on account of any first-aid treatment or other medical services rendered in connection with an emergency during my tenure as a volunteer with BBK.
5. I understand that the services I provide to BBK may include activities that may be hazardous to me including, but not limited to, lifting, or moving heavy objects. As a volunteer, I hereby expressly assume risk of injury or harm from these activities and release and forever discharge BBK from all liability.
6. The risk of contracting illness is always present and cannot be entirely eliminated. While providing volunteer services to BBK, unknown to BBK or its other volunteers, I may be in close proximity to individuals who could potentially be infected with illness. WITH KNOWLEDGE OF THESE RISKS, I AGREE TO ACCEPT ANY AND ALL RISKS OF PERSONAL INJURY OR ILLNESS OR DEATH RELATED TO ILLNESS CONTRACTED DURING THE TIME THAT I AM VOLUNTEERING WITH BBK.
7. I agree to follow the current CDC public health guidelines. I will self-monitor for signs and symptoms of COVID-19 and, if I experience symptoms of illness within 14 days after volunteering with BBK, I will notify Maureen Ryan, Volunteer Manager at maureen@booksbetweenkids.org or 832-831-1402 x802.
